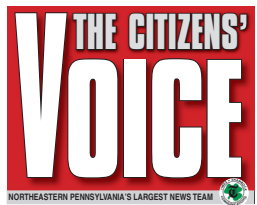

Pauly Friedman

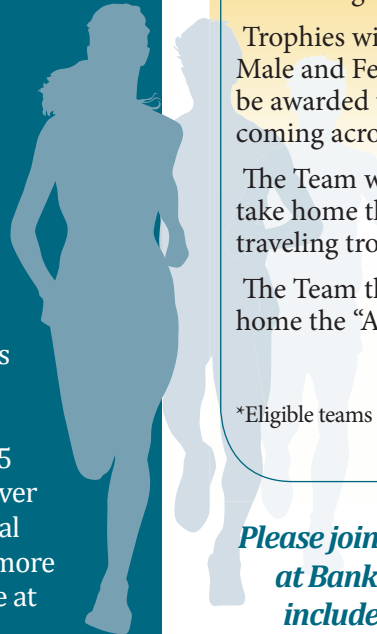
