For purposes of the following waiver, the term shall include each licensed vendor officially participating in the Freeland Pub Run (hereinafter "the Activity"). Nothing in this waiver shall be construed to limit the applicability of any of the provisions to any Participating Establishments.

**IN CONSIDERATION** for being permitted to participate in the Activity and in exchange for the agreed upon application fee, I, for myself, my heirs, personal representative or assigns, do hereby covenant not to sue, do release, do waive, and do discharge Freeland Borough, its officers, employees, and agents, as well as the Freeland Chamber of Commerce, Pub Run committee, its agents, from any and all claims including the negligence of Freeland Borough, its officers, employees, and agents and the Freeland Pub Run, its officers, employees and agents, resulting in personal injury, accidents, or illness (including death) and property loss arising from, but not limited to, participation in the Activity.

**ASSUMPTION OF RISKS:** Participation in the Activity carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. As with any physical activity, the risks vary in degree and range from 1) minor injuries such as scratches, bruises, and sprain; 2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks, and concussions; to 3) catastrophic injuries including paralysis and death.

**I have read the previous paragraphs and I know, understand and appreciate these and other risks that are inherent in the Activity. I hereby assert that my participation is voluntary and that I knowingly assume all such risks.**

**INDEMNIFICATION and HOLD HARMLESS:** I also agree to INDEMNIFY AND HOLD the Freeland Borough and/or Freeland Chamber of Commerce and/or the officers, employees, and agents of either HARMLESS from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement in the Activity and to reimburse them for any such expenses incurred.

**SEVERABILITY:** The undersigned further expressly agrees that the foregoing waiver and assumption of the risks agreement is intended to be as broad and inclusive as is permitted by the law of the Commonwealth of Pennsylvania and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

**ACKNOWLEDGEMENT OF UNDERSTANDING:** I have read this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily, and I intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by the law.
